

**NCPGC'S 2011 NATIONWIDE PRIDE DOE FUTURITY
ROUND ONE**

Nominate the dam. The fee is \$10.00. This allows you to nominate any or all of her doe kids to participate. You need not own the doe to nominate her. You may enter at any time before the deadline of 12/1/2011 by filing the Dam Nomination Form and the Kid Entry Form(s) and paying the appropriate fees. All Forms can be found on pages 3-5.

Enter her doeling(s). Kids must be born in 2011. The fee is \$10.00 per doe kid. You may enter at any time before the deadline of 12/1/2011 by filing the Dam Nomination Form and the Kid Entry Form(s) and paying the appropriate fees.

Show the doeling(s) in NPGA sanctioned shows between 1/1/2011 to 12/31/2011 to accrue points in their age classes as shown in the tables below. Kids earn points for both class and championship wins. You must own the kid to accrue points, but you do not have to show the kid yourself. If the kid is sold the points accrued are passed to the new owner. You must file the Points Accrual Form with either the show secretary's signed statement or the MEMO Issue and Page number for the show results, or a signed statement from the show secretary containing the necessary information for the points to count. Deadline for receipt of Points Accrual Forms is 1/5/2012.

The prize is half the doeling entry fees. The owner of the kid at the futurity deadline receives the prize. The owner of record is either the one as shown on the NPGA Registration or on an NPGA Transfer dated no more than 30 days from the last points accruing win.

Nominate the dam. The fee is \$10.00. This allows you to nominate any or all of her buck or wether kids to participate. You need not own the doe to nominate her. You may enter at any time before the deadline of December 1, 2011 by filing the Dam Nomination Form and Kid Entry Form(s) and paying the appropriate fee. All Forms can be found on pages 3-5.

Enter her buckling(s) or wether(s). Kids must be born in 2011. The fee is \$10.00 per buck kid. You may enter at any time before the deadline of December 1, 2011 by filing the Dam Nomination Form and the Kid Entry Form(s) and paying the appropriate fee.

Show the buckling(s) in NPGA sanctioned shows between 1/1/2011 to 12/31/2011 to accrue points in their age classes as shown in the tables below. Kids earn points for both class and championship wins. You must own the kid to accrue points, but you do not have to show the kid yourself. If the kid is sold the points accrued are passed to the new owner. You must file the Points Accrual Form with either the show secretary's signed statement or the MEMO Issue and Page number for the show results, or a signed statement from the show secretary containing the necessary information for the points to count. Deadline for receipt of Points Accrual Forms is 1/5/2012.

The Prize is half the buckling/wether entry fees. The kid's owner at the deadline receives the prize. The owner of record is either the one shown on the NPGA Registration or on an NPGA Transfer dated no more than 30 days from the last points accruing win.

If entering Doe kids or Buck/Wether kids from the same dam she must be nominated twice.

Round 2 will be from 1/1/2012 to 12/31/2012.

The winning kids will be awarded half the kid entry fees.

The Doe with the most points from her winning kids will win 25% of the Doe nomination fees.
